Conditions of Licensing for Solicitors, Peddlers and Transient Merchants

The following information explains the rules for conducting business as a Solicitor, Peddler or Transient Merchant in the City of Shakopee. Please sign the bottom of the form after reviewing it carefully to confirm that you have received, and understand the conditions. Failure to sign could result in a denial of your license.

Solicitors/Peddlers/Transient Merchants are prohibited from the following:

- Conducting business before 8:00 a.m. or after 8:00 p.m.
- Calling attention to that person's business by crying out, blowing a horn, ringing a bell, or by any loud or unusual noise, or by use of any amplifying device
- Failing to display proof of license or registration, and produce valid identification when requested
- Knocking on the door of a home that has a "No Solicitation" sign displayed
- Remaining on the property of another when asked to leave
- Claiming endorsement by the city based on license or registration
- Conducting business in any manner as to create a threat to the health, safety, and welfare of a specific individual or the general public.

Any license issued may be suspended or revoked by a Police Officer if the licensee has violated City Code, or is otherwise conducting business in such a manner as to constitute a breach of peace, fraudulent conduct, or any conduct that is prohibited by local, State, or Federal laws. Falsification of information required for a license or registration is also grounds for denial, suspension, or revocation of a license, or suspension or revocation of registration.
