PREAPPROVAL: All proposed work or materials proposed to be donated and installed shall be at the approval of City staff and staff may require written and/or drawn information to be approved prior to work being approved. Work listed on this application is not approved until staff review has been completed. Proposed work dates must be coordinated at least one week in advance with staff, but staff reserves the right to refuse or cancel proposed work dates for any reason.

WAIVER: Any and all volunteers of the group or other persons while engaged in the performance of any work or service performed under this application shall not be considered employees of the City, and any and all claims that may or might arise under the Worker's Compensation Act of Minnesota on behalf of said employees or other persons while engaged, and any and all claims made by any third party of the group's volunteers or other persons while so engaged on any of the work or services to be rendered shall in no way be the obligation or responsibility of the City. All group participants (or their legal guardians) must sign this waiver prior to participating in any activity.
