PROJECT UPDATE AND SCHEDULE

The contractor, Rosti Construction, has completed all hydrant removals and relocations on the project. No more water shutdowns are anticipated for the rest of the project.

The contractor began driveway removals. They started on the east side of the project on Gateway Drive and are working west towards Canterbury Road (CSAH 83).

Driveway construction may be a 2-week process from start to finish if your business is having a new driveway constructed. To keep access for your business, the contractor anticipates pouring half of the driveway at a time, leaving the other side open for vehicles to enter and exit.

The contractor anticipates paving the trail after construction of all driveway entrances are complete.

IRRIGATION SYSTEMS

If you have an irrigation system and it was disturbed during construction of the 12th Avenue Trail project, it will be repaired by the contractor. A schedule for irrigation system repairs has yet to be determined.

In order to maintain the project schedule, the City has authorized the contractor to work from 7 a.m. to 7 p.m., Monday through Friday. Extended hours beyond 7 p.m. and work on Saturdays (9 a.m. to 5 p.m.) may occur when necessitated and approved by the city.

ROAD & DRIVEWAY ACCESS

The contractor is required to maintain access to your business for the duration of driveway construction. There will be a period of time after concrete curb and gutter and concrete commercial driveway aprons are constructed when access to your driveway will be restricted to a single lane to allow the concrete to cure. Please contact Alex Enyi, to discuss any special considerations or related hardship issues.
