## **CONTRACT**

Shakopee City Council awarded a contract for the Red Oak Trail project to the low bidder, Max Steininger Inc., of Eagan, MN on June 15th, 2021. There are no direct assessments to property owners on this project.

### **PROJECT SCOPE**

The project consists of constructing a new multi-use bituminous trail on city owned property between Whitehall Road and Southbridge Parkway. Trees will also be planted as part of the project.

Work is beginning this week with the stripping and stockpiling of topsoil. Trail grading is also anticipated to be completed this week, and the aggregate base for the trail will be installed early next week. Trail base course paving and concrete pedestrian ramp installation will follow shortly after. Tree planting and turf restoration will follow, and the final lift of bituminous will be competed in mid-August.

The project is required to be complete by the end of September 2021.

### SPRINKLERS & DOG FENCES

It is not anticipated that irrigation systems or underground fences will be impacted. However, for those that will have trees planted along their property lines, please mark the portions of your sprinkler system and/or underground fence adjacent to the project area. The contractor will make the best attempt to protect sprinkler systems and dog fences but will be responsible for fixing them if damaged during construction.


