#### PROJECT UPDATE AND SCHEDULE

Concrete curb and sidewalk removals at existing street and driveway crossings along the trail will be removed the week of June 13. New concrete will be poured back shortly after. Approximately one week after the new concrete is poured, the trail will be reclaimed. Excess reclamation material will be hauled away, and the remaining gravel base will be prepped for paving.

The trails will be closed during construction and reopened as soon as construction is complete.

### **IMPACTS TO YOUR YARD**

The area of your yard immediately adjacent to the trail will be disturbed to allow for the construction of the trail and pedestrian ramps. There may be impacts to shrubs or plants that are adjacent (within 1-2 feet) to the trail. The City recommends transplanting any shrubs or plants until the project is complete. The City will restore the turf and landscape mulch adjacent to the trail, but will not replant any shrubs or plants removed during construction.

Please mark the portions of your sprinkler system or underground fence adjacent to existing trail and the curb and gutter as soon as possible. The contractor will be responsible for protecting or repairing irrigation systems and dog fences damaged from construction.
