### PROJECT UPDATE AND SCHEDULE

#### WESTON COURT AND GREENWOOD COURT

Concrete replacements are complete, and the new sidewalk has been installed. Turf restoration is complete. Traffic signs that were removed to allow for construction were reinstalled. The final lift of asphalt has been paved and striping is complete.

#### **GORMAN STREET**

Concrete replacements are complete. The first lift of asphalt has been paved for the street and trail. Turf restoration will occur the week of June 27. The final lift of asphalt for the trail will be paved the week of July 4. The final lift of asphalt for the street will be paved the week of July 11.

#### **ROAD & DRIVEWAY ACCESS**

It is our intent to maintain access to your driveway throughout the project. There will be occasional short-term disruptions to access during utility excavation and construction. Residents should expect full access from 7pm to 7am each day. In addition, there will be 7 days after concrete curb and gutter and concrete driveways are constructed when access will be restricted to allow the concrete to cure. Please contact Adam, to discuss any special considerations or related hardship issues.

## **SPRINKLERS**

The contractor will try to avoid damaging sprinkler systems during construction. Any damage caused by the contractor will be repaired by them. Please contact Adam if your sprinkler system is damaged during construction.
