CONTRACT

Shakopee City Council awarded a contract for the 2023 Bituminous Pavement Rehabilitation to the low bidder, Bituminous Roadways, of Mendota Heights, MN on April 18th, 2023. There are no direct assessments to property owners on this project.

PROJECT SCOPE

The project consists of milling the surface of the roadway, crack repair, patching areas of pavement failure and then paving a bituminous overlay.

Broken and settled concrete curb and gutter and ADA deficient pedestrian ramps will be reconstructed at the start of the project. The milling of the street, crack repairs, paving of the street and trail work will begin following the completion of all concrete work. This work is anticipated to be completed within one week of milling the streets. The actual paving on your street should take less than half of a day. The contractor is tentatively set to begin the project in Area A and Area B the week of May 1st. Work in Area C and Area D will begin near the end of May or early June. **(See project location map on the back for more information)**

The contractor will be posting temporary signs in the boulevards notifying residents of any parking restrictions during construction. Please use caution and patience while driving in the construction zone and comply with all parking restrictions and temporary traffic control.

The project is required to be complete by the beginning of September 2023 for all areas.

SPRINKLERS & DOG FENCES

Broken and settled concrete will be removed and replaced. Please mark the portions of your sprinkler system and/or underground fence adjacent to curb and gutter as soon as possible. The contractor will make the best attempt to protect sprinkler systems and dog fences but will be responsible for fixing them if damaged during construction.

ROAD & DRIVEWAY ACCESS

It is our intent to maintain access to the driveways throughout the project. There will be occasional short-term disruptions due to milling and paving operations.

WE NEED YOUR HELP!

Please do not walk or drive on new concrete for 7 days. When the contractor is working on your street, please be patient and for everyone's safety, please follow the directions given by the workers. Shortly before overlaying the roadway, the contractor will apply a bituminous tack coat to the surface. **We recommend that you avoid driving on this tack coat as it may track onto your driveway from your tires.** Also, please avoid driving on the fresh pavement until it has been rolled and avoid parking on it until it has had a chance to cool.

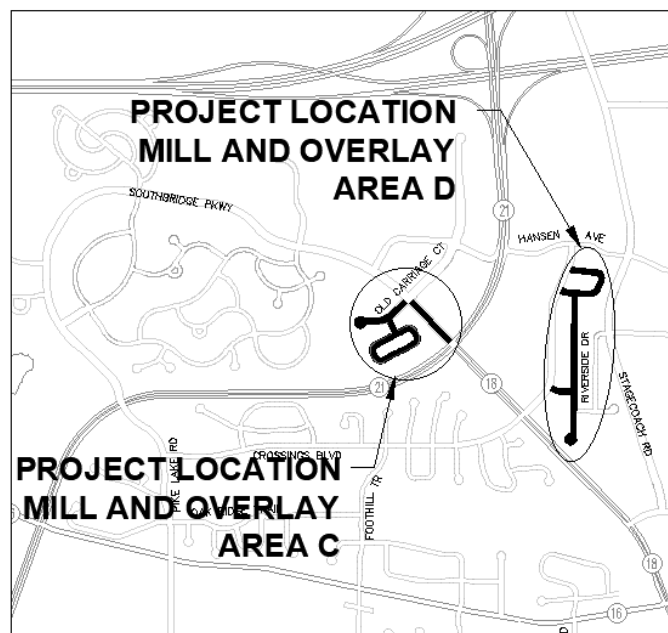
2023 BITUMINOUS OVERLAY PROJECT LOCATION MAP
