

# 2023 BITUMINOUS PAVEMENT REHABILITATION PROJECT

## CONTRACT

Shakopee City Council awarded a contract for the 2023 Bituminous Pavement Rehabilitation to the low bidder, Bituminous Roadways, of Mendota Heights, MN on April 18th, 2023. There are no direct assessments to property owners on this project.

#### **PROJECT SCOPE**

The project consists of full depth pavement patching and crack sealing to address areas of pavement failure. Upon completion of patching and crack sealing, a chip seal coat will be applied to the streets. Two separate contractors will be performing the work. The contractor responsible for patching and crack sealing anticipates beginning work the week of May 8th completing their work by the end of May. The seal coat contractor anticipates beginning their work between July and August. The actual work will only take a couple days to complete. Please check the website for any changes in the contractor schedule.

The contractor will be posting temporary signs in the boulevards notifying residents of any parking restrictions during construction. Please use caution and patience while driving in the construction zone and comply with all parking restrictions and temporary traffic control.

The entire project is anticipated to be complete by late September 2023.

#### **ROAD & DRIVEWAY ACCESS**

It is our intent to maintain access to the driveways throughout the project. There will be occasional short-term disruptions due to patching and seal coat application operations.

### WE NEED YOUR HELP!

When the contractor is working on your street, please be patient and for everyone's safety, please follow the directions given by the workers. Also, please avoid driving on the fresh bituminous pavement until it has been rolled and avoid parking on it until it has had a chance to cool.
