## CONTRACT

Shakopee City Council awarded a contract for the 2023 Bituminous Pavement Rehabilitation to the low bidder, Bituminous Roadways, of Mendota Heights, MN on April 18th, 2023.

## PROJECT LOCATION

- Dominion Avenue (Northeast of Promise Ave)
- Leavitt Woods Lane
- Maple Trail
- Wood Duck Trail (East of Maple Trail)
- Wolf Ridge Avenue

## PROJECT SCOPE

The project consists of full depth pavement reclamation of the existing bituminous roadways. The reclaimed material will be utilized as aggregate base and a new bituminous surface will be paved. The reconstruction of this area will entail excavating a depth of 2 feet minimum into the current road section and replacing the existing material with a 1-foot sand section, 8-inches of reclaimed aggregate base and 4-inches of bituminous asphalt. Drain tile will be installed in the sand section of the road to help with draining water in the subgrade of the road.

## PROJECT SCHEDULE

The contractor anticipates starting work the week of June 5<sup>th</sup>. They will begin with reclaiming the streets. After reclaiming streets, they will begin roadway excavation and backfilling with sand material and the reclaim material. Then they will pave the 1<sup>st</sup> 2-inch lift of bituminous pavement followed by restoration of the boulevard. After restoration is complete, they will pave the final 2-inch lift of bituminous wear course. This work is anticipated to take 1 month to complete barring any changes in schedule because of weather or other unforeseen issues.

## ROAD & DRIVEWAY ACCESS

It is our intent to maintain access to your driveway throughout the project. There will be occasional short-term disruptions to access during excavation and construction. Residents should expect full access from 7pm to 7am each day. In addition, there will be 7 days after concrete driveways are constructed when access will be restricted to allow the concrete to cure. Please contact Alex, to discuss any special considerations or related hardship issues.

## SPRINKLERS & DOG FENCES

The city right-of-way extends approximately 15 feet from the edge of the roadway. Please mark any underground pet fencing and mark the portions of your sprinkler system within the city right-of-way as soon as possible. Contact Alex if any fence or sprinkler is damaged during construction.

## LANDSCAPING

Please remove all landscaping and vegetation you want to save in the city right-of-way, from the edge of roadway to approximately 10 feet back. Contact Alex if you would like to know the removal limits and/or impacts adjacent to your property.

## GARBAGE CONTAINERS

Please have your container curbside before 7a.m. regardless of the condition of your street. Occasionally the contractor will move your garbage container on pickup day to help facilitate garbage collection. Please put your address on the top of your container to ensure the containers get returned to the correct property. Your garbage will be picked up on the same day as normally scheduled.
