A RESOLUTION OF THE CITY OF SHAKOPEE, MINNESOTA

ACCEPTING BIDS AND AWARDING A CONTRACT IN THE AMOUNT OF \$3,894,662.58
TO BITUMINOUS ROADWAYS, INC., FOR THE 2024 MILL AND OVERLAY AND BITUMINOUS PAVEMENT
REHABILITATION PROJECT CIF-24-011, CIF-24-012, CIF-24-013, PA-24-01, PA-24-03 AND BA-24-005

WHEREAS, Bituminous Roadways, Inc., 1520 Commerce Drive, Mendota Heights, MN 55120, is the lowest responsible bidder for the 2024 Mill and Overlay and Bituminous Pavement Rehabilitation Project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SHAKOPEE, MINNESOTA AS FOLLOWS:

- 1. The appropriate City officials are hereby authorized and directed to enter into a contract with Bituminous Roadways, Inc., in the name of the City of Shakopee for the 2024 Mill and Overlay and Bituminous Pavement Rehabilitation Project according to the plans and specifications therefore approved by the City Council and on file in the office of the City Clerk.
- 2. The City Clerk is hereby authorized and directed to return forthwith to all bidders the deposits made with their bids, except that the deposits of the successful bidder and the next lowest bidder shall be retained until a contract has been signed.
- 3. Pursuant to Section 1.150-2(d) of the Treasury Regulations, the City Council declares its official intent to reimburse itself for the costs of the improvements from the proceeds of tax-exempt bonds.
