PROJECT SCOPE

The project consists of milling the surface of the roadway, crack repair, patching areas of pavement failure and then paving a bituminous overlay. Broken and settled concrete curb and gutter and ADA deficient pedestrian ramps will be reconstructed prior to milling of the surface.

SCHEDULE UPDATE

AREA E – The contractor anticipates starting removals of pedestrian curb ramps and deficient curb and gutter the week of April 29th and reconstructing the pedestrian curb ramps and curb the week of May 6th. Milling of the bituminous roadways will begin the week of May 12th and paving to take place by the end of the week of the 12th.

AREA F - The contractor anticipates starting removals of pedestrian curb ramps and deficient curb and gutter the week of April 29th and reconstructing the pedestrian curb ramps and curb the week of May 6th. Milling of the bituminous roadways will begin the end of the week of May 6th or the beginning of the week of May 12th and paving to take place by the end of the week of May 12th.

AREA G - The contractor anticipates starting removals of deficient curb and gutter the week of May 8th and reconstructing the curb the week of May 12th. Four damaged storm sewer manhole catch basins will be replaced along Valley Park Drive the week of May 5th. Milling of the bituminous roadways will begin the week of May 12th and paving to take place the week of May 19th.
